- Bourke, Joanna. *Rape: Sex, Violence, History*. Berkeley, CA: Counterpoint, 2007. This is a wide ranging, well written treatise on rape by a British historian.
- Brown, Brene. *Braving the Wilderness: The Quest for True Belonging and the Courage to Stand Alone*. New York: Random House, 2017. Brown is a research professor of social work who specializes on shame. She has written several books and emphasizes vulnerability as the key to overcoming shame. While not writing from an overtly biblical perspective, her work are very insightful, practical and helpful.
- Buchwald, Emilie, Pamela Fletcher, and Martha Roth, eds. *Transforming a Rape Culture*, rev. ed. Minneapolis: Milkweed Editions, 2005.
- Carnes, Patrick. *The Betrayal Bond: Breaking Free of Exploitive Relationships*. Deerfield Beach, FL: Health Communications: 1997. In this excellent nontechnical book, Carnes explains the concept of a trauma bond, how it happens to trauma victims, and how victims can break the cycle.
- Clark Kroeger, Catherine and James Beck, eds. *Healing the Hurting: Giving Hope and Help to Abused Women*. Grand Rapids: Baker, 1998.
- _____. Women, Abuse, and the Bible: How Scripture Can Be Used to Hurt or Heal. Grand Rapids: Baker, 1996. This is one of the few substantial treatments of abuse and the Bible. It contains a wealth of helpful material.
- Finkelhor, David. *Childhood Victimization: Violence, Crime, and Abuse in the Lives of Young People*. Oxford: Oxford University Press, 2008. This is a well-researched, insightful treatment of violence in the lives of children which challenges the status quo. Finkelhor is one of the world's leading authorities on child abuse.
- Herman, Judith Lewis. *Trauma and Recovery: The Aftermath of Violence--from Domestic Abuse to Political Terror*, 2nd. ed. New York: BasicBooks, 1997. This is a landmark secular treatment of trauma.
- Katz, Jackson. *The Macho Paradox: Why Some Men Hurt Women and How All Men Can Help.* Naperville, IL: Sourcebooks, 2006. This is an incredibly balanced secular book on violence against women. Katz is solution oriented.
- Langberg, Diane. *Suffering and the Heart of God: How Trauma Destroys and Christ Restores*. Greensboro, NC: New Growth Press, 2015. This is superb overview of abuse trauma for Christian leaders and therapists by one of the country's leading Christian abuse experts. This work is particularly well-informed theologically.
- Levine, Peter and Maggie Kline. *Trauma-Proofing Your Kids: A Parent's Guide for Instilling Confidence, Joy, and Resilience*. Berkeley, CA: North Atlantic Books, 2008. This is a unique and very helpful resource.
- Smedes, Lewis. *Shame and Grace: Healing the Shame We Don't Deserve*. Grand Rapids: Zondervan, 1993. This is a masterful Christian treatment of shame.
- Thompson, Curt. *The Soul of Shame: Retelling the Stories We Believe about Ourselves*. Downers Grove, IL: InterVarsity, 2015. This is an excellent theologically informed treatment of shame by a Christian psychiatrist.

This workbook carefully guides men and women in the critical process of healing from the effects of abuse. Each chapter includes healing art, contemplative meditations on Christ, and journaling exercises.

- wonderful tool for ministering to traumatized children. It was originally created for use in Africa and is available from the American Bible Society in various languages. Margaret Hill, Debbie Braaksma, and Lyn Westman. *Bringing Healing to Traumatized Children: Leaders Manual*. Nairobi: Paulines Publications of Africa, 2009. As the title indicates, this book guides the teacher in utilizing *Bringing Healing to Traumatized Children*.

- Barshinger, Clark and Lojan LaRue. *Haunted Marriages: Overcoming the Ghosts of Your Spouse's Childhood Abuse*. InverVarsity, 1995.
- Bell, Roy and Stanley Grenz. *A Betrayal of Trust: Sexual Misconduct in the Pastorate.* InterVarsity Press, 1995. This is a superb treatment of sexual abuse among the clergy, and should be read by every pastor.
- Brownmiller, Susan. *Against Our Will: Men, Women, and Rape*. New York: Simon & Schuster, 1975. This is a classic feminist treatise on the history of rape and male abuse of sexual power. While evangelicals will reject Brownmiller's radical anti-male conclusions, her analysis of the historical problem is as insightful as it is disturbing.
- Cameron, Catherine. *Resolving Childhood Trauma: A Long-Term Study of Abuse Survivors*. Thousand Oaks, CA: Sage, 2000. This is an insightful treatment of childhood sexual trauma based on a longitudinal study of 51 childhood incest survivors.
- Courtright, John and Side Rogers. What to Do When You Find Out Your Wife Was Sexually Abused. Grand Rapids: Zondervan, 1994.
- Denhollander, Rachel. What Is a Girl Worth?: My Story of Breaking the Silence and Exposing the Truth about Larry Nassar and USA Gymnastics. Carol Stream, IL: Tyndale House, 2019. This is an extremely well written personal account of the Larry Nassar sexual abuse case, one of the largest of its kind in US history. It reveals the complexity of grooming by perpetrators and the effects of CSA on victims.
- Ferree, Marnie. *No Stones: Women Redeemed from Sexual Shame*. Longwood, FL, Xulon, 2002. This is an excellent book for women struggling with shame from sexual brokenness caused by sexual addiction, abuse, and promiscuity.
- Gay, Roxanne, ed. *Not that Bad: Dispatches from Rape Culture*. New York: Harper, 2018. This is a collection of extremely well written, brutally honest essays on sexual abuse. It is written from a very secular perspective.
- Herman, Judith Lewis. *Father-Daughter Incest*, 2nd ed. Cambridge, MA: Harvard University Press, 2000. This is one of the best secular books on incest in print.
- Kearney, Timothy. Caring for Sexually Abused Children: A Handbook for Families and Churches. Downers Grove, IL: InterVarsity, 2001.

- . *The Secret Trauma: Incest in the Lives of Girls and Women*. New York: Basic Books, 1986. This is a landmark book on incest based on a careful, large-scale study that demonstrated that the prevalence and consequences of incest have been greatly underestimated.
- Salter, Anna. *Predators, Pedophiles, Rapists, and Other Sex Offenders: Who They Are, How They Operate, and How We Can Protect Ourselves and Our Children.* New York: BasicBooks, 2003. This is a fantastic non-technical overview of sex offenders by one of the nation's leading secular experts.

 - This is one of the best secular textbooks in print on the treatment of sexual abuse.
